OUR LOW BARRIER DAY CENTER PROVIDES UNACCOMPANIED HOMELESS WOMEN WITH A STABLE AND SAFE ENVIRONMENT TO RECUPERATE FROM THE DAILY STRUGGLE OF HOMELESSNESS AND EXTREME POVERTY. THE DAY PROGRAM IS OPEN SIX DAYS A WEEK AND WE AVERAGE APPROXIMATELY 100 - 120 WOMEN PER DAY. DURING THE DAY PROGRAM, WOMEN CAN GET A BITE TO EAT, DO LAUNDRY, SHOWER AND REST. LOCAL AGENCIES IN BEHAVIORIAL HEALTH AND MEDICAL HOLD COUNSELING SESSIONS TO HELP THE WOMEN WITH NEEDED SERVICES. AT THE END OF THE YEAR, WE WILL HAVE HAD APPROXIMATELY 25,000 VISITS. THE NIGHT PROGRAM PROVIDES OVERNIGHT STAYS FOR WOMEN WHO WOULD OTHERWISE BE SLEEPING OUTSIDE. 35 WOMEN SPEND THE NIGHT ON
